2. <u>Discussion and possible action re: Board Member Donna Wyatt's involvement in unethical practices in attempting to acquire Fire Chief's EMS Certifications.</u>

A motion that Board Member Donna Wyatt be censured for unethical practices for the balance of her term as Director with stipulations that she only engage in board fiduciary business, not operational matters, and will not enter the fire station property at 14022 S. Sunland Gin Road, unless requested to do so by specific request of the Fire Chief, Board Chairman, or for Board Meetings was made by Clerk Bailey. The motion died for lack of a second.
